4.1 Description of first aid measures

- Eye contact** : Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Stop if the exposed person feels sick as vomiting may be dangerous. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

7.1 Precautions for safe handling

8.2 Exposure controls
